The Health and Safety Advisor is a leader of safety excellence, responsible for ensuring compliance of the Environmental, Health and Safety (EHS) plan and assisting in the supervision of the project, and by being present in the work areas.

Duties:

- Administer the EHS Program
- Promote the highest level of safety throughout Mosaic Transit Group
- Provide direction and support for managers, supervisors, sub-contractors regarding their responsibilities for maintaining a positive and inclusive safety culture
- Ensure all workplace parties fulfill their responsibilities for the EHS program
- Have good working knowledge of Occupational Health (OHSA) and Safety legislation and Workers' Safety
- and Insurance Board (WSIB) policies
- Participate/support "pre-planning" stages of work
- Assist in the management of worker's compensation claims
- Conduct workplace safety audits
- Walking the project sites with workers' safety representatives to assess safety and to address deficiencies
- Other duties as assigned
